WHEREAS:

**The First Party is a UGC Approved University College based in Surat and**

**The Second Party is engaged in Chemical Manufacturer based in Panoli.**

A) The First & Second Party do believe that collaboration and co-operation between themselves will promote more effective use of each other's resources to provide each of them with enhanced opportunities.

B) Both Parties are intent to cooperate and focus on activities for mutual benefit and these include Skill Based Training, Education, Internships, Placements, Industrial Visits and Expert Lectures.

## CLAUSE 1 CO-OPERATION

1.1 Both Parties will cooperate to facilitate effective utilization of the infrastructure and intellectual capabilities of both organizations.

## CLAUSE 2 SCOPE OF THE MoU

2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party.

2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and inhouse requirements.

2.3 Placement of students: second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and inhouse requirements.

2.4 Financial Commitment: There is **no** financial commitment on the part of either party and if there is any financial consideration, it will be dealt separately.

2.5 Approvals: Both Parties will obtain necessary internal approvals, consents and permissions for the smooth implementation of this MoU.

## CLAUSE 3 VALIDITY

3.1 This Agreement will be valid for one year till 27<sup>th</sup> March 2026 unless it is expressly terminated by either Party by giving one months' notice to the other party.

## CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES


4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
