CLAUSE 1 CO-OPERATION

CLAUSE 2 SCOPE OF THE MoU

2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party.

2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.

2.3 Placement of students: second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements.

2.4 Financial Commitment: There is **no** financial commitment on the part of either party and if there is any financial consideration, it will be dealt separately.

2.5 Approvals: Both Parties will obtain necessary internal approvals, consents and permissions for the smooth implementation of this MoU.

CLAUSE 3 VALIDITY


3.1 This Agreement will be valid for one year till 02/04/2026 unless it is expressly terminated by either Party by giving one months' notice to the other party.
