- 2.3 Placement of students: Second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in-house requirements. ## CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

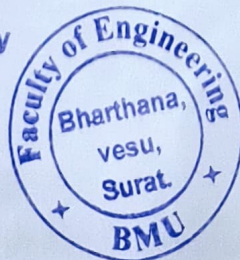
4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
