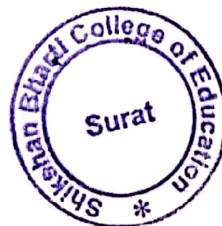

CLAUSE 2 SCOPE OF THE MoU

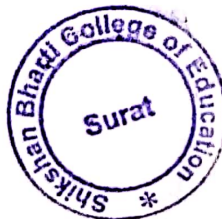


